**GOVERNMENT OF JAMMU AND KASHMIR**  
**DIRECTORATE OF COMMAND AREA DEVELOPMENT JAMMU.**

Subject:- Final seniority list of Ministerial/Executive staff (Non-Gazetted) borne on the establishment of Command Area Development, Department Jammu.

**Circular**

Whereas, a tentative seniority list of Ministerial/ Executive staff (Non-Gazetted) borne on the establishment of Command Area Development Department Jammu was issued among all the subordinate offices working under the Administrative control of this Directorate vide this office circular No:-CAD/Adm/S.List/2020-21/08-33 dated:-24.04.2020 and also uploaded on official website [www.cadjmu.nic.in](http://www.cadjmu.nic.in) of this Directorate.

Whereas, it was asked to all the Drawing and Disbursing officers to display the seniority list at prominent place on the notice board and also to be shown to each of the officials working in their office/scheme to make them aware about their seniority position and in case of any objection, the representation of the aggrieved employee with authenticated proof/ supporting documents were desired to be submitted with recommendations within a period of 30 days from the date of issue of the tentative seniority list.

Whereas, objections to the tentative seniority list issued by this Directorate were received from the following employees regarding different claims mentioned against each which are examined and redressed as below.

1. Sh. Ghulam Mohd Malik, Field Asstt. working in the office of Asstt. Soil Cons. Officer, CAD Sub Division Sarore represented alongwith original certificate of being member of socially and educational backward class issued by the Tehsildar Jammu for inclusion of OSC category against his name in the seniority list. Based on documentary proof and further genuineness of certificate obtained from Tehsildar Jammu, the category of the official has been incorporated in the seniority list.
2. Sh. Parveen Kumar, Field Asstt. working in the office of Project Officer, Soil and Water Management CAD Jammu represented alongwith original certificate of being member of socially and educational backward class issued by the Tehsildar Bishnah for inclusion of OSC category against his name in the seniority list. Based on documentary proof and further genuineness of certificate obtained from Tehsildar Bishnah, the category of the official has been incorporated in the seniority list. Besides, the official had also requested for inclusion of 10+2 qualification in the seniority list which has not been included because he has acquired the said qualification from JKBOSE during his service without obtaining permission from this Directorate.
3. Sh. Naresh Kumar, Plant Protection Operator, working in the office of Sub Divisional Agri. Officer Dayalachak represented alongwith an undertaking that he belongs to General category but Scheduled caste category is mentioned against his name in the seniority list. The correction with regard to the deletion of S/C category against his name has been undertaken in the seniority list.
4. Sh. Krishan Kishore, Junior Asstt. Working in the office of Asstt. Soil Cons. Officer CAD Dayalachak represented that he has qualified type test on 18.12.2018 and confirmed by the DPC in its meeting held on 28.01.2019 whereas S/Sh. Rajinder Singh, Surjeet Singh, Tarlochan Singh, Junior Asstt. qualified the type test of on 25.05.2019 and confirmed by the DPC in its meeting held on 23.09.2019 and accordingly he is senior to them. From the perusal of record, it has been found that all the Jr. Asstt. have been confirmed by the DPC in its meeting held during Sept. 2019 wherein the official Sh. Krishan Kishore has been confirmed as Jr. Asstt. from 25.05.2019 after the clearance of all the above 03 Jr. Asstt. and said position has been assigned to the official in the seniority list. Hence the objection of the official has been found devoid of merit hence rejected.

5. Smt. Sunita Koul, Jr. Asstt working in this Directorate represented that she was adjusted as Jr. Asstt. on 09.03.2007 alongwith grade benefits and accordingly she may be assigned the seniority position from the date of holding the grade/monetary benefit of the post of Jr. Asstt. Further, stated that she had qualified the Computer training course from DOEACC under Ministry of information Technology GOI under certificate No. EDES/112 dated:-29.06.2009 for which she was deputed by the Directorate vide CAD order No. 113/E of 2007 dated:-19.07.2007 as per directions of the Govt. From the perusal of record, it was noticed that the official was adjusted as Jr. Asstt. vide CAD order No:- 44/E of 2007 dated:-09.03.2007 and later on grade of the post of Jr. Asstt. was released vide CAD order No. 119/E of 2007 dated:-20.07.2007, further in-situ promotion in the Pay scale Rs.5200-20200+2400 was granted to the official vide CAD order No. 91/E of 2016 dated:-07.10.2016 w.e.f.01.04.2016. Besides, the official has qualified the type test on 18.12.2018 and subsequently confirmed by the DPC for the post of Jr. Asstt w.e.f:25.05.2019 in its meeting held during Sept.2019 and order to this effect was issued vide CAD order No.111/E of 2019 dated:-05.10.2019. However, her case was examined in light of Govt. Order No.743-GAD of 2007 dated:- 28.06.2007 issued by the General Administration Deptt. wherein, it has been clarified that promotion of Govt. employee shall take effect from the date he/she has been formally put in charge of the higher post subject to his/her eligibility in accordance with the Recruitment Rules and availability of vacancy. His/her clearance/regularization shall take effect from the date of his placement against the higher post or availability of vacancy or the date of his/her eligibility whichever is later. In all other cases, the promotion of the Govt. employee to the next higher post shall take effect from the date of issuance of the order. It has been found that the official was released the grade benefit for the post of Jr. Asstt. on 09.03.2007, the vacancy was available on 01.08.2007 and she became eligible on 29.06.2009 and as such holding the sanctity of earlier orders, it is expedient to consider the confirmation of Smt. Sunita Koul to the post of Jr. Asstt. regularly w.e.f. 25.05.2019 and w.e.f. 29.06.2009 notionally for the purpose of fixation of seniority. Now she shall figure at S.No. 3 above Shri Rajinder Singh & below Shri Surinder Kumar.
6. Sh. Subash Chander, Senior Asstt. working in the office of Asstt. Soil Cons. Officer CAD Sub Division Supwal represented for placing him above Sh. Rattan Chand Dansalia, Senior Asstt. in the seniority list being senior in initial appointment. From the perusal of record it was found that neither Sh. Rattan Chand Dansalia nor Sh. Subash Chander passed the type test held during 1998 against the minimum speed of 30 words/minute prescribed for the post of Jr. Asstt. in the Draft Recruitment Rules of the Deptt. However, just there was a requirement, one performing better was given precedence and promotion in violation of norms and rules. His case was examined in light of J&K Classification Control and Appeal rules 1956 says that "it is always permissible for the State to rectify an error which was committed while fixing the seniority earlier. The re-fixation, however, should be made on the strength of record and should not cause manifest injustice or prejudice." Hence, it would be appropriate to operate the initial seniority list where both were similarly placed one as Peon Sh. Subash Chander since 20.09.1988 and other Sh. Rattan Chand Dansalia as Peon regularised from daily wager w.e.f. 01.04.1994. Hence, Sh. Subash Chander, Senior Asstt. is placed above Sh. Rattan Chand Dansalia, Senior Asstt. in the seniority list being senior in initial appointment and date of further promotions to the post of Jr. Asstt. and Senior Asstt of both the officials are same.
7. S/Sh. Rakesh Chander, Kulbir Singh, Girdhari Lal, Parveen Kumar, Mohd Wazir, Field Asstt. Gr-II represented that Sh. Nek Ram, Field Asstt Gr-II placed at S.No.04 in the tentative seniority list is junior to them. From the perusal of record, it revealed that Sh. Nek Ram, (initially appointed as Chowkidar) who belongs to S/C. category was existing after Sh. Kulbir Singh, (initially appointed as Surveymate) in the previous seniority list, has been cleared by the DPC as Field Asstt. against Scheduled caste promotion quota at S.No.21 while Sh. Kulbir Singh, Surveymate has been cleared as Field Asstt. against Gen. Category at S.No.22 and accordingly the seniority position of Sh. Nek Ram, Field Asstt. has been changed and placed above Sh. Kulbir Singh, Field Asstt. in the latest seniority list. Further, the officials had also represented


that S/Sh. Sham Lal, Som Nath and Om Parkash, Plant Protection Mechanic are also junior to them. It is found that the above officials are cleared against the post of PPM in accordance with J&K Agri. Subordinate Service Recruitment Rules SRO-442 dated:-23.10.2017 under class V(B) Schedule II and thereafter there is no further promotion of these officials after PPM. Whereas, S/Sh Rakesh Chander, Kulbir Singh, Girdhari Lal, Parveen Kumar, Mohd Wazir, are cleared against the post of Fd. Asstt.Gr-II in accordance with J&K Agri. Subordinate Service Recruitment Rules SRO-442 dated:-23.10.2017 under class V(A) Schedule II prefers BAT officials which class allows further promotion upto the post of JAEOS. Besides, the seniority and promotion prospectus of these two cadres PPM and Field Asstt. are being maintained separately and it does not interrupt one another. Therefore the objection of the officials was devoid of merit and hence rejected.

8. Sh. Rajinder Singh, Jr. Asstt. presently on deputation to Agriculture Deptt. in the office of Chief Agriculture Officer Poonch represented for placing him above Sh. Surinder Kumar, Jr. Asstt. in the seniority list being senior in initial appointment. While going through the record, it was found that Sh. Rajinder Singh, has been confirmed by the DPC in its meeting held during Sept.2019 for the post of Jr. Asstt. from the date of clearance of type test i.e.25.03.2016 the date on which he became eligible as per conditions laid down in the J&K Secretariat Subordinate Service Recruitment Rules 2009 issued vide SRO.186 dated:-08.07.2009 applicable to this Deptt. vide Administrative Deptt. letter No.Agri/E-33/97/CAD dated:-04.08.2015 and same position has been assigned to the official in the seniority list. However, his claim for placing him senior to Sh. Surinder Kumar Junior Asstt. only on the basis of being senior in initial appointment is unreasonable and hence rejected.

Now therefore based on the record and in supersession to previous seniority lists issued by this Directorate from time to time, a final seniority list of Ministerial/Executive staff (Non- Gazetted) borne on the establishment of Command Area Development Department Jammu enclosed herewith is hereby circulated for information of the employees.

This shall however be subject to outcome of writ petition, if any pending before the court of law and shall not confer any preferential right outside the purview of rules applicable.


